Greetings Parents

I am Sgt. Derrick Dunson. I am the Dare and School Resource Officer (SRO) here at Hunt Elementary School. It is a pleasure to serve the students of HES. We believe that every student at HES should have the opportunity to come and leave a Safe Learning Environment. The safety of the children is one of our main priorities. Several parents have raised concerns about the safety of their child while being dropped off or picked up here at HES. To reinforce the safety of your child during arrival and dismissal on the car ramp, the following guidelines will be followed.

- 1. ALL PICKUP PARENTS OR DRIVERS MUST HAVE A HES PROVIDED GREEN CAR TAG VISIBLE IN THEIR VEHICLE. IF ADDITIONAL SLIPS ARE NEEDED, THEY WILL BE AVAILABLE FOR PURCHASE IN THE FRONT OFFICE FOR \$2.**
- 2. NO PARENT WILL BE ALLOWED TO GET OUT OF THEIR VEHICLES AND WALK UP TO THE PICK UP AREA TO GET A CHILD.**
- 3. YOUR CHILD WILL BE ESCORTED TO THE VEHICLE BY AN ADULT OR A SAFETY PATROL MEMBER.**
- 4. NO CHILD WILL BE ALLOWED TO BE DROPPED OFF BEFORE 7:30 A.M. IF YOU DROP OFF YOUR CHILD BEFORE THE GIVEN TIME AND LEAVE HIM/HER UNSUPERVISED, YOU WILL BE CONTACTED FOR POSSIBLE CHILD NEGLECT AND CRIMINAL CHARGES MAY APPLY.**
- 5. PICK UP WILL START PROMPTLY AT 3:35 P.M., ALL DRIVERS WILL ADHERE TO THE TRAFFIC CONTROL DEVICES AND SPEED.**
- 6. NO PARENT WILL BE ALLOWED TO CHECK THEIR CHILD OUT OF SCHOOL AFTER 3:00 P.M.**

The "CAR TAG" will include the child's name, their homeroom teachers' name, and an assigned number. Once the system is in place, no child will be allowed to get into a vehicle if they are not listed on the "CAR TAG".

If your child is going to be picked up by someone that does not have a "CAR TAG", you will be required to contact the front office before 2:30 P.M., so that this information is communicated to the teachers and the SRO Officer in a timely manner. Your child will be given a slip from the office when a change is made in their transportation home. The "CAR TAG" system, as well as the other procedures, will ensure that HES is continuing to be a Safe Learning Environment.
